Declaration of Quorum and Call to Order:

• General Manager District Update:

General Manager, Russell Labus mentioned that we received an invoice for \$20,000 from the Nueces River Authority for educational services. Mr. Labus said that Sky Lewey, with the NRA, mentioned that even with the current pandemic they are still going to make an effort to provide educational services to the schools but that the Rain Barrel Project will be on hold for this year. Mr. Labus stated that Management Plan has been submitted to the TWDB for prereview.
